Registration

Event Registration within the AEF ISOBUS Database is required to attend all or part of the Plugfest activities. Registration will open March 8th and close **on April 7th**. Test Matrix

AEF will prepare a Test Matrix of equipment connections for the Plugfest. The Test Matrix is a schedule of connections between each service-type product (e.g. terminals) and each client-type product (e.g. implement controllers) for a **fixed amount** of time.

To be included in the Test Matrix, participants must separately register equipment details by completing an Equipment Registration Form online within the AEF ISOBUS Database following event registration. Participants will have the opportunity to review the **equipment list** by April 22nd before it is finalized.

New objectives

In order to gain valuable information to improve AEF products, all participants will be encouraged to submit all bugs uncovered during the Plugfest to a centralized repository. This collected data can be used to improve DB and CT as well as increase test coverage. Details will be forwarded with the final test matrix.

In addition, the tested software must be classified using the selections shown below:

Possible selection to identify tested software:

- Status of certification of tested software?
 - Software is already certified
 - Software is already certified but includes new software parts based on already tested Functionalities and Options
 - Software is not certified, because software is under development
 - Software is not certified, because Conformance Test is not available
 - Software is not certified and will never be certified (e.g. base software development, ISOBUS libraries, no product...)
